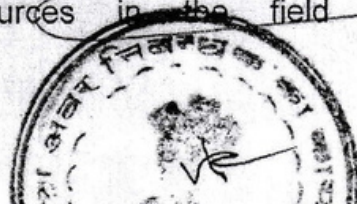

d. Establishing institutions to impart technical education and obtain recognition & affiliation from Govt. and other competent forum(s)/authority(s) & shall do/take all the necessary things/steps for the attainment of its objects.

e. Running & promoting any type of educational set -up with or without the financial assistance of the people and/or Government for the welfare of the general mass. Running & promoting any type of educational set -up with the partial financial assistance of the people and/or Government and partially from own resources for the welfare of the general mass.

f. Organizing EDUCATIONAL CAMP, CAREER COUNSELLING CENTRES to educate the masses about the latest development and vistas of education & shall do/take all the necessary things/steps for the attainment of its objects.

g. h. The trust shall open & run all types of educational institution and shall undertake educational activities & shall do/take all the necessary things/steps for the attainment of its objects.

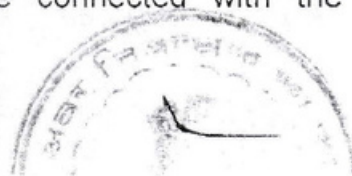
i. The Trust shall open & run all types of professional/technical institutions and shall take all the necessary things/steps for the attainment of its objects.

j. The trust is established to part education for the welfare of the general mass, therefore the trust shall do and/or shall take all necessary steps which are required for the attainment of its educational objectives.

All the income, earnings, movable and/or immovable properties of the Trust shall be solely utilized and applied towards the promotion of its aims and objects only and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profit or in any manner whatsoever to the present Trustee or to any persons claiming through any one of present or past Trustee. No Trustee shall have any personal claim on any movable and / or immovable properties of the Trust or make any profit whatsoever by virtue of his or her Trusteeship, provided that nothing herein shall prevent payment of any remuneration to any officer or to any employee of the Trust or to any Trustee of the Trust or to any other person for services actually rendered by them in connection with the aims and objects of the Trust.

## 2. PROPERTY VESTED IN THE TRUSTEE

The founders jointly do hereby transfer a sum of Rs. 50,000/- (Rupees Fifty Thousand only) in favour of the Trust and unto the Trustee thereof. The Trustee shall hold the said fund and other properties that may be endowed or conferred in favour of the said Trust for the use and benefit of the trust. The Trustee shall, out of the income realized from the properties endowed and such other endowments or donations or receipts which they may get, pay all taxes and rates, and all expenditure connected with the Trust.

6. POWER OF TRUSTEE:-

The Trustee will also have the following powers:-

- i. To apply the whole or part of the income or accumulation thereof or whole or part of the corpus of the Trust properties for one or more of the objectives of the trust as the Trustee may from time to time determine.
- ii. To amalgamate the Trust with any other Trust or society for wholly public charitable purposes.
- iii. To convert and get in the Trust properties and/or to vary the investment for the time being.
- iv. To invest and keep invested the trust properties in the purchase of immovable properties or in other assets specified in section 11 (5) of the Income Tax Act, 1961 and to alter vary and transpose such investment from time to time as the Trustee shall, in their absolute discretion, think fit, in any case the funds of the trust shall not be invested in any of the manner which is not permissible by relevant provisions of Income Tax Act, 1961 applicable at any given time.
- v. The Trustee shall have powers to sell or assign any movable and immovable property or properties for the time being forming part of the Trust fund either together or in parcels and either by public auction or private contract and either with or without any special or other stipulation as to title, evidence of commencement of title or otherwise and to buy or rescind or vary any contract for sell or to resell without being made answerable for the loss occasioned thereby and for the purposes aforesaid or any of them to execute and do all such assurances, acts, deeds and things as they shall think fit and out of the moneys which shall arise from any such sale for the interest and of the Trust or otherwise in or about the execution of any of the trusts or powers of these presents and shall stand possessed of the residue of the

### 3. BOARD OF TRUSTEE

a. The Board of Trustee will ordinarily consist of not less than Three and not more than Seven members. The Founders and Authors of the Trust, Ms. Shahina Khan and Mr. Tarique Raza Khan shall hold office for life and other trustee shall hold office for the period of three years or as decided by the chairman of the trust. The Trustee may co-opt other persons to the Board of Trustee as may be necessary, from time to time.

b. The Trustee co-opted shall hold office for Three years only, at the end of which they shall retire automatically, The Trustee whose term of office expires after the period of three years are eligible to be co-opted as Trustee again by the existing Trustee. A Trustee may, if he/she so desire, resign his/her Trusteeship even before the expiry of the term of his/her Trusteeship.

c. The Trustee shall appoint from among the founder Trustee, or their nominees a Managing Trustee of the Board of Trustee, who shall act as Chairperson and preside at all the meetings of the Trust and the Board of Trustee. The managing Trustee shall hold his office on rotational basis.

### 4. MEETINGS OF THE BOARD OF TRUSTEE

a. The Board of Trustee shall meet as often as necessary but at least twice a year and their proceedings shall be recorded regularly in the Minutes Book of the Trust to be maintained for the purpose.

b. All the meetings of the Board of Trustee shall be convened by one of the founder Trustee.

c. In the absence of the Managing Trustee at any meeting, the Trustee present may elect from among themselves the Chairperson of the meeting.

### 5. QUORUM

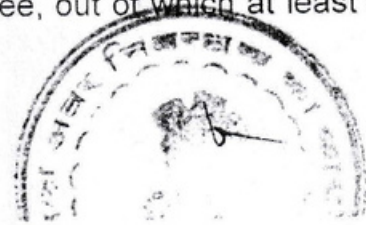

vi. To invest, dispose off, transfer and otherwise deal with the subject matter of the Trust in such manner as the Trustee deem fit and proper to do carrying out the objects of the trust.

vii. To open accounts with any Bank or post office for the purpose of keeping the moneys of trust, to operate such accounts including over draft accounts and to give instructions to the Bank or Post office and to provide for opening and operation of such accounts by Managing

Trustee or Trustee or agents appointed by the Trustee as per situation from time to time.

xiii. The Trustee shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think proper, persons or agents and to appoint committees as they may think necessary to function under the authority and control of the Trustee for carrying out the Trust of these presents or the management thereof and may within the limits of their own powers invest them with all such powers including power to incur all such expenditures as may be necessary for carrying out the objects of the Trust.

xiv. The Trustee shall be at the liberty to allow and permit any other Trust, Institution or charity in any local area whose objects are the same or to similar to those of these presents to be amalgamated with the trusts, created these presents to the intent and effect that such other Trust, institution or charity shall be deemed to be a part and parcel of the Trust of these presents, provided, that no conditions are accepted which, involve a change in the name of the trust or are inconsistent with or repugnant to the objects thereof.

xv. To pay all costs, charges, and expenses incidental to the management, administration and execution of the trusts and powers herein contained.

xvi. To purchase or hire or to take on lease lands, buildings and other immovable and movable properties in the name of Trust.

xvii. To raise or borrow moneys required for the purpose of the trust on mortgage or pledge of the Trust Estate or any part thereof with or without any security and at such rate of interest and on such terms as the Trustee shall think fit.

xviii. To do such acts and things which may be incidental and necessary to attain the objectives of the Trust.

5. DUTIES OF THE TRUSTEE:-

- i. The Trustee shall be chargeable only for such moneys, stocks, shares and funds that shall actually come into their hands and shall not be answerable or accountable for neglect default acts of omission or commission of the other Trustee nor of any Bankers or other persons with whom the Trust properties or any securities may have been deposited or handed or unless caused by their willful neglect or default.
- ii. All the Trustee shall be bound to maintain and defend all such suits, and (subjects to provision of this deed) to take such other steps as may be reasonable required for the conservation of the Trust property and the assertion or protection of the title.

6. RIGHTS OF THE TRUSTEE:-

- i. The Trustee will not be entitled to receive any remuneration as Trustee but may reimburse themselves of all expenses actually incurred by them in connection with trust or their duties relating thereto.
- ii. The Trustee may from time to time associate with the activities of Trust any person or persons of Public eminence as patron or patron in chief and may appoint or make provisions for appointment of committee or managing Committee or Board of Directors for the conduct of the affaires of the Trust consisting wholly of the Trustee or partially of Trustee and partially of others as the Trustee may decide for the purpose of administration of any projects or scheme/s institution/s academic institution (s) established or undertaken by the Trust in consonance with the objects of the trust. by the Board of Trustee. The chairman of the Trust shall be the principal executive and head of such committee (s) viz. managing committee (s) or the Board of Director's constituted by the Board of Trustee. The Committee, Managing Committee or Board of Directors shall work under the direct control and supervision of the Board of Trustee.

iii. The Trustee may from time to time frame schemes, rules regulations, laws and bye-laws for regulating the affairs of the project undertaken by the Trust in pursuance of the various objects, such rules as framed by the Board of Trustee for the conduct of affairs of the project shall be binding and no deviation shall be permissible in any of the rules so framed by any authority whatsoever connected with the said project without the prior approval of the Board of Trustee.

iv. (a) The Trust shall have an advisory committee of National Level to advice the Trustee on the activities of the trust and to suggest how to make them better serve its aim and objects. The strength of the Advisory committee shall not exceed 7 (Seven) at a given time. The members of the Advisory committee shall serve the trust in honorary capacity but they may be reimbursed such, expenses as may be incurred by them for attending the meetings of the Advisory Committee, if so decided by the Trustee.

(b) The Advisory Committee appointed by the Board of Trustee shall function under the direct control of the trust and the chairman of the Board of Trustee shall act as ex-officio chairman of the said Advisory Committee.

It is declared that the Trust setup under this deed of Declaration if the Trust fails or for any reason, in the opinion of the Trustee, the net assets of the Trust, both movable and immovable, shall be handed over to any other body having the same or similar objects, as decided by the Two-Third majority of the Trustee at that time.

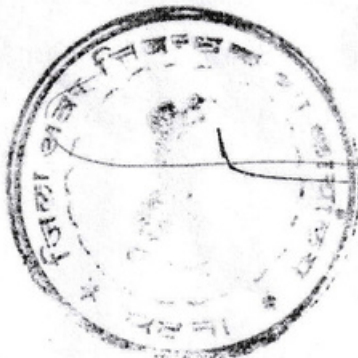
#### 9. AMENDMENTS

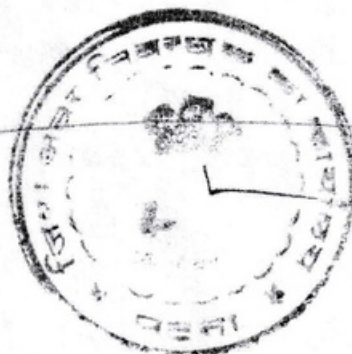
